As of December 31, 2013, the Company's net assets were \$3.5 billion, and its net asset value per share was \$35.08. As of December 31, 2013, the Company's asset coverage ratio under the 1940 Act with respect to senior securities representing indebtedness was 421% and the Company's asset coverage ratio under the 1940 Act with respect to total leverage (debt and preferred stock) was 309%.
