KAYNE ANDERSON MLP INVESTMENT COMPANY ANNOUNCES ITS NET ASSET VALUE AT JUNE 30, 2007

LOS ANGELES, CA – August 1, 2007 – Kayne Anderson MLP Investment Company (the “Company”) (NYSE: KYN), today announced its net asset value at July 31, 2007.

At July 31, 2007, the Company’s net assets were \$1.5 billion and its net asset value per share was \$33.75, based on 43.0 million shares outstanding.
