### KAYNE ANDERSON MLP INVESTMENT COMPANY ANNOUNCES ITS NET ASSET VALUE AT AUGUST 31, 2007

LOS ANGELES, CA – September 4, 2007 – Kayne Anderson MLP Investment Company (the “Company”) (NYSE: KYN) today announced its net asset value at August 31, 2007.

At August 31, 2007, the Company’s net assets were \$1.4 billion and its net asset value per share was \$31.40, based on 43.0 million shares outstanding.

At August 31, 2007, the Company’s total assets and long-term investments were \$2.3 billion. Long-term investments were comprised of Midstream MLPs (78%), Upstream MLPs (6%), Propane MLPs (5%), MLP Affiliates (4%), Coal MLPs (3%), Shipping MLPs (2%) and Other (2%).
