As of July 31, 2016, the Company's net assets were \$2.2 billion, and its net asset value per share was \$19.32. As of July 31, 2016, the Company's asset coverage ratio under the 1940 Act with respect to senior securities representing indebtedness was 438% and the Company's asset coverage ratio under the 1940 Act with respect to total leverage (debt and preferred stock) was 287%.
