KAYNE ANDERSON MLP INVESTMENT COMPANY ANNOUNCES ITS NET ASSET VALUE AT DECEMBER 31, 2006

LOS ANGELES, CA - January 2, 2007 - Kayne Anderson MLP Investment Company (the "Company") (NYSE: KYN), today announced its net asset value at December 31, 2006.

At December 31, 2006, the Company's net assets were \$1.1 billion and its net asset value per share was \$29.38, based on 38.1 million shares outstanding.

At December 31, 2006, the Company's total assets were \$1.8 billion and long-term investments were \$1.8 billion. The Company's ten largest holdings by issuer (exclusive of short-term investments) at December 31, 2006 were:
