

Kayne Anderson MLP/Midstream Investment Company Provides Unaudited Balance Sheet Information and Announces its Net Asset Value and Asset Coverage Ratios at May 31, 2020

Houston, TX – June 2, 2020 – Kayne Anderson MLP/Midstream Investment Company (the "Company") (NYSE: KYN) today provided a summary unaudited statement of assets and liabilities and announced its net asset value and asset coverage ratios under the Investment Company Act of 1940 (the "1940 Act") as of May 31, 2020.

As of May 31, 2020, the Company's net assets were \$891 million, and its net asset value per share was \$7.04. As of May 31, 2020, the Company's asset coverage ratio under the 1940 Act with respect to senior securities representing indebtedness was 700% and the Company's asset coverage ratio under the 1940 Act with respect to total leverage (debt and preferred stock) was 336%.

The Company had 126,447,554 common shares outstanding as of May 31, 2020.

As of May 31, 2020, equity and debt investments were 99% and 1%, respectively, of the Company's long-term investments of \$1.3 billion. Long-term investments were comprised of Midstream MLP (73%), Midstream Company (24%), Renewable Infrastructure/Utility Company (2%) and Debt (1%).
