As of April 30, 2017, the Company's net assets were \$2.3 billion, and its net asset value per share was \$19.70. As of April 30, 2017, the Company's asset coverage ratio under the 1940 Act with respect to senior securities representing indebtedness was 390% and the Company's asset coverage ratio under the 1940 Act with respect to total leverage (debt and preferred stock) was 291%.
