### KAYNE ANDERSON MLP INVESTMENT COMPANY ANNOUNCES ITS NET ASSET VALUE AT MARCH 31, 2008

LOS ANGELES, CA – April 1, 2008 – Kayne Anderson MLP Investment Company (the “Company”) (NYSE: KYN), today announced its net asset value as of March 31, 2008.

As of close of business March 31, 2008, the Company’s net assets were \$1.2 billion and its net asset value per share was \$26.51, based on 43.4 million shares outstanding.

As of March 31, 2008, the Company’s total assets were \$2.0 billion and long-term investments were \$1.9 billion. Long-term investments were comprised of Midstream MLPs (77%), Upstream MLPs (6%), Propane MLPs (5%), MLP Affiliates (5%), Coal MLPs (4%), Shipping MLPs (1%) and Other (2%).
