LOS ANGELES, CA - May 1, 2007 - Kayne Anderson MLP Investment Company (the "Company") (NYSE: KYN), today announced its net asset value at April 30, 2007.

At April 30, 2007, the Company's net assets were \$1.4 billion and its net asset value per share was \$34.04, based on 42.0 million shares outstanding.
