Holders of record as of November 13, 2015 of the Series E MRP Shares (including the shares being redeemed) will receive the regular monthly dividend payment amount of \$0.088542 per share on December 1, 2015. On December 21, 2015, holders will receive \$25.059027 per Series E MRP Share redeemed, which is equal to the liquidation preference per share of \$25.00, plus accumulated but unpaid dividends of \$0.059027. The paying agent is American Stock Transfer & Trust Company, which is the Company's transfer agent.
