### KAYNE ANDERSON MLP INVESTMENT COMPANY ANNOUNCES ITS NET ASSET VALUE AT MAY 31, 2007

LOS ANGELES, CA - June 1, 2007 - Kayne Anderson MLP Investment Company (the "Company") (NYSE: KYN), today announced its net asset value at May 31, 2007.

At May 31, 2007, the Company's net assets were \$1.5 billion and its net asset value per share was \$34.13, based on 42.9 million shares outstanding.
